- 6. Copy of audited financial statements for last 2 years (signed pages displaying audit opinion and Statements of Financial Position, Comprehensive Income, Changes In Funds and Cashflow will suffice)
- 7. Evidence of previous or recent referees, service completion certificate or LPOs with public institutions or
- non-governmental organisations for the last 2 years (including contact details of previous clients) 8. Evidence of proven knowledge, expertise, and experience in the provision of goods and services for a minim
- 8. Evidence of proven knowledge, expertise, and experience in the provision of goods and services for a minimum of two years
